Navigating Through New Mooring Guidelines

MEG4 has a dedicated appendix explaining the testing and documentation steps necessary for manufacturers to demonstrate they have followed the OCIMF guidelines. When all necessary steps have been completed, the manufacturer enters the information into a Line/Tail Base Design Compliance Certificate which is then reviewed and endorsed by an "Independent Inspector" (typically from a classification society).

OCIMF - Offshore Vessel Inspection Database. The Offshore Vessel Inspection Database (OVID) was developed in response to a request from OCIMF members to provide a database of offshore inspections broadly following the format of SIRE.

1 Under the Original 1993 Programme, the inspecting OCIMF Member was free to choose whatever inspection protocol and report format it desired. In 1997, the Uniform Vessel Inspection Procedure changed this. The Vessel Particular Questionnaire was a newly developed OCIMF document, also introduced in 1997 and was not part of the original programme.
